Day in the Life of a House Official Reporter

Our team will provide a glimpse of the long history of the House Office of Official Reporters, discuss the general organizational structure and types of support services that the House Office of Official Reporters provides to the United States House of Representatives, and finally, offer a synopsis of the day in the life of a reporter working on Capitol Hill, including reporting on the House floor and committee assignments. The team will also provide an overview on the role that the House Office of Official Reporters play for significant historical events, such as the President's State of the Union Address, other Joint Sessions and Meetings of Congress, special investigations and select committees of Congress, and the Inauguration of the President.

- The different support services and organizational structure the House Office of Official Reporters provide the United States House of Representatives
- A synopsis of what it's like to be a reporter working on Capitol Hill
- The roles reporters have played in significant historical events

She then returned to freelancing until accepting the position as Official Reporter for the House in early 2014. Katy lives in a condo in Capitol Hill with her husband and their dog Wesley. She enjoys traveling and spending time outdoors hiking and biking.

Julie Schoettle, RPR, has been working at the House of Representatives for almost 2 years as an Official Reporter supporting committee assignments. Julie relocated from Lansdale, Pennsylvania with her family to pursue her dream career. Julie graduated from Arcadia University with a bachelor's degree in criminal justice, minor in business administration. From there, she enrolled in Orleans Technical Institute for Court Reporting. After graduating, she went to work in the First Judicial District
